# 7. Remarks, audit findings and proposal for improvements:

- 2.4 Welding procedures are discussed with the welding team at the start of the job, procedures are consulted and available in the office but are not kept on site. This condition is controlled and acceptable.
- 3.2 3.4 reorganization of the building is in progress, welding consumables are temporarily stored in a heated container which serves as office as well. Present conditioning is not practical for storage, control of temperature and humidity. Heater is operational for drying electrodes whenever necessary.
- 4.4 Hoisting material, is serviced by extern service supplier on a yearly base, certificates are available and equipment tagged. Notices hoisting equipment without tag (although the certificate is available) Segregation of defective hoisting equipment not to be used to be improved. Noticed chain hoists without safety latch on same location as the hoists in use.
- 4.8 4.9 Pre-heating equipment available on site post heating is outsourced to an external service supplier
- 5 NDT is outsourced to an external approved service supplier.
